1 Call to Order, Roll Call of Board Members, and Introduction of Guests

Chair Hofmann called the meeting to order at 10:01 A.M. and read the roll call. Since all but one of the Board members were in attendance, there was a quorum. Chair Hofmann welcomed the visitors and asked them to introduce themselves.

2 Adoption of Agenda

Mr. Schietzelt moved that the agenda be adopted as presented. The motion was seconded by Dr. Evans and carried by unanimous vote.

3 Approval of Minutes from the 175th Meeting

Draft minutes of the 175th meeting were distributed to Board members prior to the meeting. No corrections were proposed so the minutes of the 175th meeting were approved as presented.

4 Report from the Illinois Department of Natural Resources

Mr. Joe Kath gave a report detailing activities of the IDNR's Office of Resource Conservation and Office of Realty and Environmental Planning. The fourth year (of eight) for the Alligator Snapping Turtle release program has been completed. There has been success with survival, but no reproduction yet. Consideration is being given to rearing mussels at the Jake Wolf Hatchery. The Department recently held its first bat festival and more than 1200 people attended. Planning is underway for the Department to host the annual meeting of the Midwest Bat Working Group at the Field Museum in April 2019.

5 Report from the Illinois Nature Preserves Commission

Ms. Kelly Neal represented an oral report and a written memorandum from the Illinois Nature Preserves Commission. The Commission's next meeting will be in January 2018.

6 Report from the Chair of the Illinois Endangered Species Protection Board

Chair Hofmann reported on her activities since the 175th meeting; her written report to the Board is attached. Activities included presiding at a September 21, 2017 meeting of the Mammal Endangered Species Technical Advisory Committee (ESTAC), preparing a report for the September meeting of the Illinois Nature Preserves Commission, and distributing draft Incidental Take Authorizations and Conservation Plans to Board members.

7 Report on Natural Areas Evaluation Committee

Dr. Evans has been attending meetings of the Natural Areas Evaluation Committee (NAEC) as the Board's representative. The NAEC reviews and updates the Illinois Natural Areas Inventory (INAI). The two most recent meetings focused largely on mussels. New sites providing habitat for unusual concentrations of mussels were added to the INAI, while other sites were removed. Dr. Capparella suggested a program to reach out to organizations such as conservation land trusts with information about protection of INAI sites.

8 Compliance with Mandatory Ethics Training for Board Members

Chair Hofmann confirmed that all Board members completed mandatory online ethics training and their certificates of completion have been filed. She pointed out that the Board's Secretary has been listed as its ethics officer who could act as a liaison with IDNR Legal Counsel.

9 Preliminary Approval of a Petition to Change the Status of the Elfin Skimmer (*Nannothemis bella*) from Threatened to Endangered

The Board discussed granting preliminary approval for changing the status of the Elfin Skimmer from threatened to endangered. The petition was submitted by Drs. Tim Cashatt and Tracy Evans. This species was only discovered in Illinois in 1985 and has very specific habitat requirements. There were two populations in northeastern Illinois, but now only one known population exists. Mr. Schietzelt made a motion to give preliminary approval to changing the status of the Elfin Skimmer from threatened to endangered. The motion was seconded by Dr. Coons and approved by a unanimous vote.

10 Approval of Potential Members of the Botanical ESTAC (Endangered Species Technical Advisory Committee) for the Revision of the List of Endangered and Threatened Plant Species

Drs. Coons and Fant contacted 72 botanists to determine their interest in serving on the Botanical ESTAC. As of the meeting date, they have had responses from 46 individuals, 29 of whom expressed an interest in the ESTAC. Upon a motion made by Mr. Ross-Shannon and seconded by Mr. Schietzelt, the following persons were approved by unanimous vote as potential members of the Botanical ESTAC: Tim Bell, Chris Benda, Rachel Goad, Bill Handel, Paul Marcum, Susanne Masi, Bill McClain, Robert Mohlenrock, Michael Murphy, Randy Nyboer, Rick Philippe, Beth Shimp, Greg Spyreas, John Taft, Gordon Tucker, Eric Ulaszek, and John Wilker. Several of these botanists have already agreed to serve on the ESTAC and Drs. Coons and Fant will contact the others.

11 Update on the Process for the Review of Listed Plant Species

Three ESTAC meetings will be held to review plants from the northern, central and western, and southern regions of Illinois. The committee will seek input from individuals knowledgeable about the flora of these regions, but only ESTAC members will vote on recommendations for listing changes. Chair Hofmann offered to provide the ESTAC members with information about

Open Meetings Act training; she and Mr. Schietzelt offered to help update data tables for listed plant species that could be distributed to ESTAC members.

12 Approval of Schedule for 2018 Quarterly Board Meetings

Upon a motion by Dr. Coons, which was seconded by Dr. Evans, the following dates were unanimously approved for 2018 Board meetings.

Chair Hofmann reserved the meeting room at Midewin for these dates.

13 Public Comment Period (3 minutes per person)

Students Abbie Besich, Malina Carli, Liam Doyle, Reese Krueger, Nayeli Negron, and Aliyah Swanson from Pleasantdale Middle School addressed the Board about their activities studying and raising awareness of the Alligator Snapping Turtle, an Illinois endangered species, and raising funds to aid the reintroduction of this species in the state. Their class has been caring for an Alligator Snapping Turtle (which will be released next summer) and, among other things, selling t-shirts to raise funds to support their activities. Members of the Board expressed their appreciation for the students' interest and efforts on behalf of endangered species. They also thanked teacher Jennifer Lauermann and principal Griffin Sonntag for encouraging the students.

14 Other Business

Chair Hofmann mentioned that since the Board has reestablished ESTACs the policy manual for these committees should be updated prior to the next review and revision of the Illinois List. She also expressed the opinion that Board members may have time at 2018 meetings to discuss basic policy issues.

15 Adjournment

There being no further business, Chair Hofmann adjourned the meeting at 11:56 A.M.
