The Ballard Nature Center received a \$1,000.00 grant from the Illinois Wildlife Preservation Fund in FY 05. The funding was for the purchase of binoculars for use in our educational programs. The project has been completed and we are now requesting the funding payment. Attached you will find the final report, photo documentation, invoices, and a newspaper article.

Final Report

The Ballard Nature Center, a non-profit 501 C 3, is responsible for the management of a 210-acre nature center located between Effingham and Altamont, IL. The legal description is Effingham County, Mound Township T. 7N. – R. 4 E. Section 2. The center's primary goals are environmental education and on-site restoration and management of natural communities typical to the Southern Till Plain Division of Illinois.

A large part of the center's goals for environmental education is accomplished through youth educational programs. The binoculars are being used in a variety of programs that already exist at the nature center, plus they will be used in new programming. The binoculars were purchased through Eagle Optics through a special program titled "Product Matching Donation Program." Eagle Optics reduced the price of their Audubon Equinox 8x42 binoculars by \$100.00 each. The Ballard Nature Center was able to purchase 10 pairs of binoculars that originally sell for \$199.99 each for \$99.99 each. These binoculars are ideal for not only bird watching, but will also be used in programs on butterflies, dragonflies, and wetlands. As part of the nature center's educational programs, children will be taught how to correctly use binoculars and will then participate in activities on viewing songbirds, shorebirds, waterfowl, dragonflies, butterflies, basking turtles & snakes, and wildlife in general.




