With the use of the chainsaw provided by the IDNR through the IWPF Grant we were able to successfully remove approximately 15 trees and numerous invasive Asian bittersweet vines, honeysuckle and buckthorn from our prairie site. We estimate to have added 1 and ¼ more acres to the existing prairie.
