#### **Program Description:**

Grant funding allowed for the development of an educational, interpretive permanent exhibit focusing on the Illinois prairie and prairie restoration. The exhibit, consisting of displays, artifacts, and live animals, is housed at the Homer Lake Interpretive Center, at Homer Lake Forest Preserve. Based on the Forest Preserve District's interpretive plan, the exhibit's natural history and cultural themes include lifecycles of the prairie, adaptation and survival of species, plant/animal migration, and impacts of the landscape on human habitation and vice versa.

The exhibit was designed to provide a positive learning experience for all ages and to give visitors an educational experience that enhances their visit to the restored prairies and other natural areas of the Homer Lake preserve. Now completed, the Interpretive Center exhibit will serve as a companion to a larger, similarly themed exhibit currently under redevelopment at the district's Museum of the Grand Prairie, in Lake of the Woods preserve in Mahomet.

#### **Educational Objectives and Outcomes:**

The project goals included:

- Provide positive learning experiences for people of all ages and abilities, following the best and most innovative interpretive and environmental education techniques.
- Educate the public about the Grand Prairie ecosystem.
- Highlight the connections between plants, animals and people.
- Foster visitors' connection to the forest preserves, and encourage sustainable behaviors and environmental stewardship.

Visitors to the Interpretive Center can now discover what life was like for early settlers to emerge from the dense forests of the eastern United States onto a wide open expanse filled with flowers and grasses more than 8 feet tall. They can learn why settlers initially thought prairie soil would be too poor for farming, and consider the challenges of slogging through deep mud in the spring and fighting wildfires in the fall. The exhibit helps explain how settlers surmounted the obstacles presented by this vast and challenging landscape, and in the span of one generation, how they profoundly altered the prairie to support an agrarian way of life.

In the second section of the exhibit, Interpretive Center visitors can explore the prairie as a national heritage. The exhibit helps to explain the importance of prairie restoration and how

the Forest Preserve District accomplishes the restoration effort. Artifacts in this section offer a look at the tools used to conduct prescribed burns, one of the most effective restoration options available to forest preserve staff.

And lastly, the exhibit also features a live box turtle and rat snake, representatives of species that depend on prairie habitats today. And visitors can learn about rare species – such as eagles and otters – that are making a comeback within our preserves.

#### **Results for the District:**

The *Life on the Prairie* exhibit was completed successfully and in accordance with its planned timeline. The exhibit opened to the public on April 1, 2013 and will remain in the Homer Lake Interpretive Center indefinitely.

Reaction to the exhibit has been overwhelmingly positive. It was skillfully designed, constructed, and displayed within the interpretive center. More than 2,800 individuals have visited the center and the exhibit so far this year, with the total number for 2013 projected at about 3,500. To accompany the new exhibit and expand its reach, the theme chosen for this year's Kids Corner coloring area was prairies. Entitled "Plant a Prairie," the exhibit highlights the beauty of prairie plants and their importance to wildlife. It also invited visitors to color a prairie plant, complete the sentence "I like prairie because . . .", and add it to the exhibit; over 70 of these sheets were added. Answers included: I like prairie because: "it's beautiful and healthy," "I like the smell," "You can see for miles," "It's awesome," "It's pretty," "It's got new things," "It's fun," "It's cute," "I like looking at the birds," and "I like the butterflies."

Some of the comments we have received about the new exhibit *Life on the Prairie* include:

- "It is so interesting to read the firsthand journal entries about the early prairie and the way the land around here looked."
- "I enjoyed reading about the American elk and their 'ivories.' Very interesting."
- "Wow, this is what they wear when they burn the prairie!"
- "Whoa, this is a bison skull, it is soooo big! I would love to be a bison." When asked why, the student said it was because he would be so big and have big horns to protect himself.
- Some students were surprised by the way the bison and elk pelts felt. They didn't think it would feel that way.
- Staff observed students reading each of the panels.

#### **Summary:**

To summarize, the *Life on the Prairie* exhibit was a successful endeavor for the Champaign County Forest Preserve, and the Homer Lake Interpretive Center. The educational objectives have been met, as evidenced by the comments provided by the visitors to the exhibit. Perhaps our most important goal in particular has been met, in that the exhibit seems to be encouraging visitors to further explore the District preserves and the other natural areas right here in Champaign County.

### New exhibit at Homer Lake shows life on the prairie

Visitors to the Homer Lake Interpretive Center will be taken back in time to life on the prairie.

The Center now features a new exhibit, Life on the Prai-

rie.

Visitors can experience the plant and animal life of the prairie and discover how humans have been impacted by the landscape throughout the years.

"We hope visitors will be inspired by the tallgrass prairie, and the peoples and animals that have called it home; and that they will leave with an appreciation for this national cultural and natural heritage," said Pam Leiter, Assistant Director, Museum and Education Department of the Homer Lake Interpretive Center.

Visitors explore what it was it was like for early settlers to emerge from the dense forests of the Eastern United States onto a wide open expanse filled with flowers and grasses over 8 feet high.

Visitors learn why settlers initially thought prairie soil would be too poor for farming, and consider the challenges of slogging through deep mud in the spring and fighting wild-fires in the fall.

"Visitors can expect to experience the stories of settlers as they encountered the tall-grass prairie — which was to them an entirely newlandscape, with unique beauties and challenges," Leiter said. "They will learn about the methods the Forest Preserve District uses

to restore prairies on its land, and about the return of some animal species, such as bald eagles, to the region."

Visitors can also learn about the techniques the district uses for restoration, including the tools used to conduct prescribed burns, and learn about the process of restoration from the ground up.

The exhibit also features a live box turtle and rat snake, representatives of species that depend on prairie habitats to-day.


Visitors can also learn about rare species - such as eagles and otters - that are making a comeback.

"This exhibit focuses on the human relationship to the Grand Prairie, from settlement to today. This is the first major exhibit at the Interpretive

Center to do so," Leiter said.
"In particular, it touches on experiences of early settlers in the 1800s, modern prairie restoration techniques, and previously-rare animal species whose populations are rebounding."

The exhibit was funded by a grant from the Illinois Department of Natural Resources from contributions to the Illinois Wildlife Preservation Fund.
