Under 62 Ill. Adm. Code 245.240 IDNR must, within five days of receiving a permit application under the HVHFF Act, provide the Office of the State Fire Marshal a copy of 1) Notice of Receipt of Application, 2) Well Site Safety Plan, 3) Containment Plan, and 4) Traffic Management Plan. You will receive a similar email for each permit application under the High Volume Horizontal Hydraulic Fracturing Act that the Department receives. This email will either come from me or someone else from IDNR's Office of Legal Services. Based on this first application, the attachments will likely be too large to attach to an email (as they were in this case). That leaves us with two options, 1) I can provide an FTP link like I did for this application, or 2) I can provide a hard copy by certified mail / hand delivery.

Hopefully this answers your question. If not, please feel free to give me a call.
