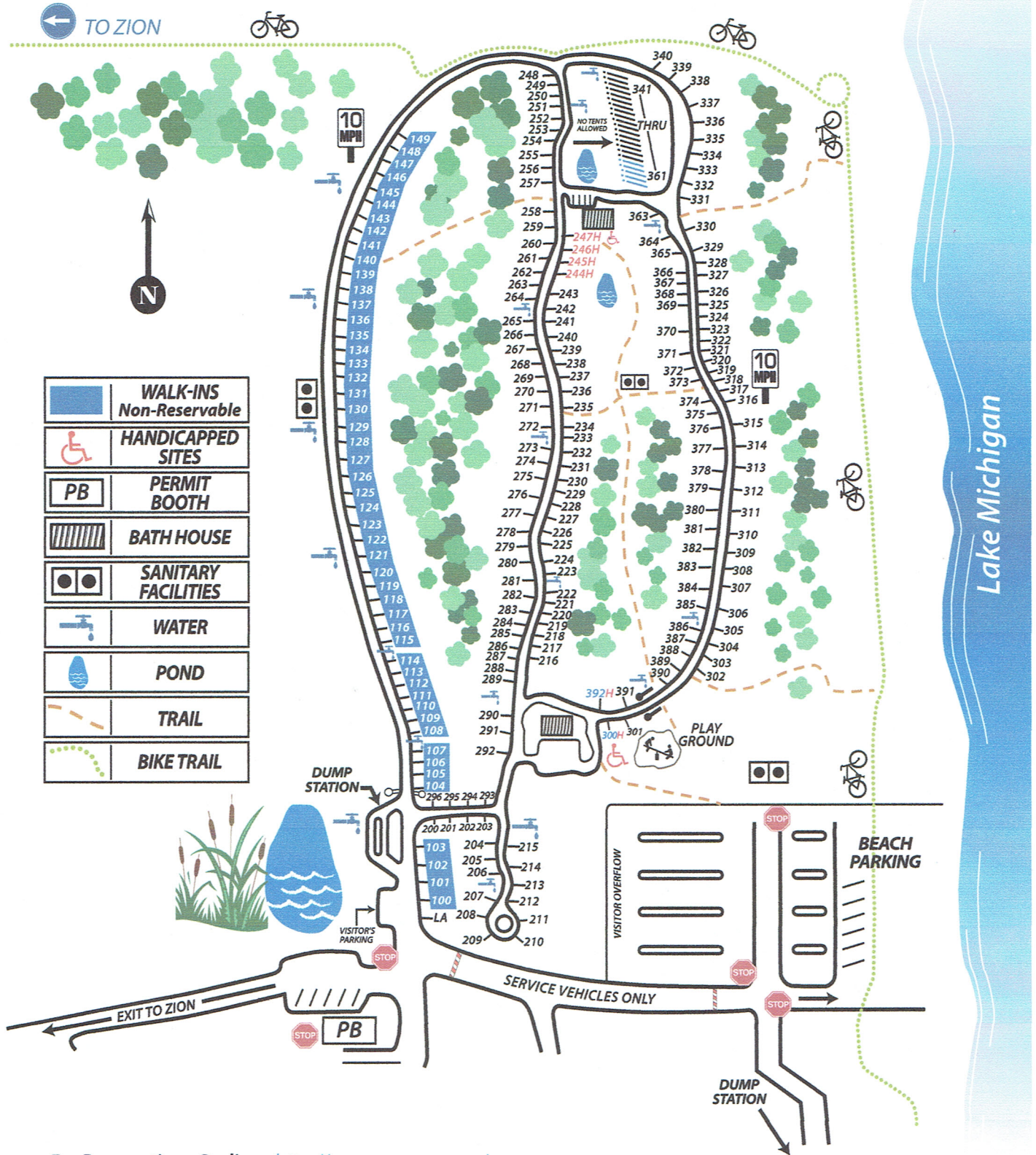

## ILLINOIS BEACH STATE PARK CAMPING RULES

### No Consumption or Possession of Alcohol Allowed on Any Campsite

1. The maximum length of stay for a camping party and/or the camping unit is limited to 14 camping nights within any 30 day period.
2. Permits may be obtained at the Campground Permit Booth during posted hours.
3. You **must have your Camping Unit/Shelter with you to obtain a Camping Permit**. Camp shelter must be put up at time of registration.
4. A "family" consists of either or both parents and unmarried minor children (18 yrs. or younger) - **NO MULTIPLE FAMILIES**. A "single group" consists of 4 unrelated adults (18 yrs or older) - **NO CHILDREN**. A group of no more than four (4) occupants may occupy up to two tents on a single campsite. A "family" may have either two tents or a trailer and a tent for the children. Each "family" must occupy separate camps.
5. **Check out is 3pm daily.**
6. Visitors (unregistered campers) must leave the park by: **9pm every night.**
7. **No more than two motorized vehicles per site.** Park on gravel pads only.
8. **No Consumption or Possession of Alcohol is allowed anywhere in the Park.** Alcohol, however, is allowed inside the Resort Hotel only.
9. **It is UNLAWFUL to drain or dispose of water/waste directly onto the ground**, including that from sink drains. Put in covered container and empty at sanitary dump stations.
10. **Quiet pets** are welcome as long as they are on a leash, not to exceed 10' and under specific physical control at all times. Do not leave unattended. Cleaning up after pets is the responsibility of each owner. Do not tie pets to trees.
11. Please observe quiet hours: **10pm to 7am**; radios, televisions, generators, and voices must be kept at a level not to disturb other campsites.
12. Please DO NOT wash dishes in the bathhouses/restrooms.
13. Keep your fires in camp stoves provided, or in your own burners.
14. NO gathering of firewood.
15. We are trying to provide and maintain shade trees for our sites, **please do not hang clothes or tie a line to the trees. Trees living or dead are not to be cut down, or damaged in any way.**
16. Washing vehicles not permitted.
17. Camper's copy of permit **must be displayed on post immediately after registering designating his/her site or you will lose your site.**
