Statistical information contained in this report is based on the Federal Fiscal Year 2022 (FFY22) (10/01/2021 – 09/30/2022), excluding the registered recreational boats, which are based on the calendar year 2022. This publication is a result of the coordinated effort of the Illinois Department of Natural Resources (IDNR) and those jurisdictions that investigate recreational boating accidents and enforce boating laws in Illinois.

#### **SCOPE**

Statistical information contained in this report is based on the Federal Fiscal Year 2022 (FFY22) (10/01/2021 – 09/30/2022), excluding the registered recreational boats, which are based on the calendar year 2022. This report contains statistics on recreational boating accidents, registered recreational boats, boating enforcement, and information on boating safety activities. Data used to compile the recreational boating accident statistics comes from two sources: (1) Recreational Boating Accident Reports of IDNR investigations of recreational boating accidents on waters within the State; and (2) reports forwarded to the IDNR by other jurisdictions within the State. Without investigations, information would not be collected from accident reports from boat operators. Data used to compile the boating enforcement statistics comes from three sources: (1) IDNR Conservation Police Officer Daily Activity Reports, (2) CPO Operating Under the Influence Reports, and (3) reports forwarded to the IDNR by other jurisdictions within the State.

#### REPORTING GUIDELINES FOR BOAT ACCIDENTS

Federal Regulations (33 CFR 174.121) require accident report data to be forwarded to Coast Guard Headquarters within 30 days of receipt by a state.

Illinois Boat Registration and Safety Act (625 ILCS 45/6) requires the operator of a vessel involved in a collision or accident must render aid (if practical) to any affected persons and provide his name, address, and vessel information to any person injured and to the owner of any property damaged as a result of the collision or accident. Failure to comply when the accident or collision resulted in a person's death or personal injury is a Class A misdemeanor. Any person who has failed to stop or comply with this section must, as soon as possible but no later than one hour after the collision or accident occurred, report the incident to the nearest police station or sheriff's office. If the operator was hospitalized, this report must be filed within one hour of discharge. If the collision or accident involves personal injury to a person, failure to comply is a Class 4 felony. Personal injury is defined as any injury requiring treatment beyond first aid. If the collision or accident resulted in death, failure to comply is a Class 2 felony punishable by 3 – 4 years in prison.

In addition to the above requirements, whenever a boat is involved in a collision or accident causing property damage of \$2000 or more, or results in total loss of the vessel, or causes injury to any person requiring medical attention beyond first aid, a report, completed by the operator, must be made to the Department, on forms provided, within five days. All boating accidents resulting in loss of life must be reported to the Department on forms provided within 48 hours by the operator.

Boat accident reporting applies to each "vessel" used by its operator for recreational purposes or vessels that are required to be numbered and are not subject to inspection.

The term "vessel" includes every description of watercraft or other artificial contrivance used, or capable of being used, as a means of transportation on the water. Terms used to describe the various types of watercraft are airboat, auxiliary sailboat, cabin motorboat, canoe, houseboat, inflatable boat, kayak, open motorboat, personal watercraft, pontoon boat, raft, rowboat, and sailboat. Unmodified inner tubes have not been determined to be "vessels" to date. Thus any accident that only involves an unmodified inner tube has not been included in the statistics in the main body of this report.

Operators of motorboats involved in a boating accident resulting in serious injury or death must submit to chemical testing (breath, blood, or urine) upon request by the investigating law enforcement officer. Failure to submit to requested testing or submitting to testing but failing such testing shall result in a suspension of the motorboat operator's Illinois driver's license by the Illinois Secretary of State.

#### **Suspension Provisions**

A person's privileges to operate a watercraft may be suspended for a period of 1 to 3 years for violations of operating under the influence, careless or reckless operation, or failure to report an accident.

Further, it shall be unlawful for any person to operate a watercraft when their privileges have been suspended or revoked in this state or by another state, a federal agency, or a province of Canada.

#### **How Do I Report A Boating Violation or Boat Accident?**

Your local Illinois State Police District HQ dispatch center dispatches Illinois Conservation Police Officers (CPOs). If you have a serious boating violation or boat accident to report, dial "911" immediately. Otherwise, contact your local Illinois State Police District HQ dispatch center for assistance contacting a Conservation Police Officer. #### "Reportable" Boating Accidents

A *vessel* is considered to be involved in a "boating accident" whenever a death, missing person, personal injury, property damage, or total vessel loss results from the vessel's operation, construction, seaworthiness, equipment, or machinery.

The following are examples of accident types that are used in this report:

- Grounding, capsizing, sinking, or flooding/swamping
- Falls in or overboard a vessel
- Persons ejected from a vessel
- Fire or explosions that occur while underway and while anchored, moored, or docked if the fire resulted from the vessel or vessel equipment.
- Water-skiing or other mishaps involving a towable device
- Collision with another vessel or object
- Striking a submerged object
- A person struck by a vessel, propeller, propulsion unit, or steering machinery
- Carbon monoxide exposure
- Electrocution due to stray current related to a vessel
- · Casualties while swimming from a vessel that is not anchored, moored, or docked.
- Casualties, where natural causes contributed to the death of an individual, but the determined cause of death, was drowning.
- Casualties from natural phenomena such as interaction with marine life (i.e., leaping sturgeon causes casualty to person) and interaction with nature (i.e., mountain side falls onto vessel causing casualties).
- Casualties are when a person falls off an anchored vessel.

#### "Non-Reportable" Boating Accidents

Not every occurrence involving a vessel is considered within the scope of the National Recreational Boating Safety Program. The following occurrences involving a vessel may be required to be reported to the state but, for statistical purposes, are excluded from this report and are considered "non-reportable" boating accidents:

- A person dies, is injured, or is missing as a result of self-inflicted wounds, alcohol poisoning, gunshot wounds, or the ingestion of drugs, controlled substances, or poison.
- A person dies, is injured, or is missing as a result of an assault by another person or persons while aboard a vessel.
- A person dies or is injured from natural causes while aboard a vessel.
- A person dies, is injured, or is missing as a result of jumping, diving, or swimming for pleasure from an anchored, moored, or docked vessel.
- A person dies, is injured, or is missing as a result of swimming to retrieve an object or a vessel that is adrift from its mooring or dock, having departed from a place of inherent safety, such as the shore or pier.
- Property damage occurs, or a person dies, is injured, or is missing while preparing a vessel for launching or retrieving, and the vessel is not on the water and capable/ready for its intended use.
- Property damage occurs when a person dies, is injured, or is missing due to a fire onshore or a pier that spreads to a
  vessel or vessels.
- Property damage occurs to a docked or moored vessel, or a person dies, is injured, or is missing from such a vessel as a
  result of storms, unusual tidal or sea conditions, or when a vessel gets underway in those conditions in an attempt to
  rescue persons or vessels.
- Property damage occurs to a docked or moored vessel due to a lack of maintenance on the vessel.
- Property damage occurs to a docked or moored vessel due to theft or vandalism.
- Property damage occurs to a person dies or is injured, or a person is missing from a non-propelled houseboat or other vessel used primarily as a residence when such a vessel is not underway.
- Casualties that result from falls from or on docked vessels or vessels that are moored to a permanent structure.
- Casualties that result from a person climbing aboard an anchored vessel from the water or swimming near an anchored vessel.
- Fire or explosions on anchored, docked, or moored boats where the cause of the fire was not attributed to the vessel or vessel equipment.
- Casualty or damage that results when the vehicle used for trailering the vessel fails.
- Casualties or damage that occurs during accidents that only involve unmodified inner tubes.
- Casualties or damage occurs when the only vessel(s) involved are being used solely for governmental, commercial, or criminal activity.
- Casualties or damage occurs when the only vessel(s) involved are not numbered and are being used exclusively for racing.
- Casualties or damage that occur when the only vessel(s) involved are foreign vessels and thus not subject to U.S. federal reporting requirements.

#### RECREATIONAL BOATING STATISTICAL SUMMARY

This report summarizes the Federal Fiscal Year 2022 Illinois Recreational Boating. Statistical information contained in this report is based on the Federal Fiscal Year 2022 (FFY22), excluding the Certificate of Numbered Vessel Reports, which is based on the calendar year 2022.

Illinois officers investigated 52 reportable boat accidents, which was a 44% decrease from FFY21. A total of 40 injuries were reported in FFY 2022, a 37% increase from the previous year. A total of 6 fatalities were reported in FFY 2022, a 62% decrease over the previous period, resulting in roughly three deaths per 100,000 registered recreational vessels.

The Illinois Department of Natural Resources Office of Law Enforcement recorded 29,794 personal service hours worked on the Recreational Boating Safety Program, which accounted for 9% of total work hours. This was a 3% increase from the total hours worked on the program in FFY 2021. The Office of Law Enforcement's estimated on-water hours of 17,671 showed a 21% increase in hours worked on the water over the preceding period.

Boating enforcement activity by the Illinois Conservation Police saw a decrease in the total number of citations and a slight increase in written warnings issued during FFY22 from the previous year. Citations decreased from 734 to 591 (-19.48%), and written warnings increased from 2697 to 2808 (4.11%). Operating under the influence arrest increased from 65 to 72 (10.76%). Personal floatation devices and operating under the influence remained the top boating violations cited by officers.

The total number of registered boats continues to decline from 188,086 last year to 187,429 this year.

Boating accident reports indicate the majority of accidents occur between June, July, and August, on Saturday or Sunday, between 12 p.m. and 6 p.m. Conditions are usually clear with good visibility, light winds, and calm water. Most accidents involve operators between the ages of twenty and forty who have over one hundred hours of boating experience but have little or no classroom boating safety instruction. They also involve open motorboats cruising in a careless/reckless manner culminating in a collision with another boat.

Six people died in 6 Illinois boating accidents.

Three fatalities occurred during the week and three on the weekend
Six fatalities with clear conditions and 4 with calm waters

The winds were light to moderate (5) with good visibility (4)

In the majority of fatalities, the operators had no formal boat safety education (6).

0 out of 6 fatalities involved alcohol/drug impairment

Once again, the factor that would have saved lives this past season would have been for people to wear their Personal Floatation Devices (PFD). Of 6 fatalities, four may have survived if they had worn their PFDs.

The State of Illinois does not require a Coast Guard-approved PFD to be worn. However, persons under the age of 13, and operators/passengers on personal watercraft or specialty prop-craft, are required to wear a Coast Guard-approved PFD.

The most proactive action a boater can take to ensure his/her safety on the water is to wear a Coast Guard-approved PFD of the appropriate size and in serviceable condition.

#### **BOATING SAFETY EDUCATION**

#### **General Information**

No person under ten years of age may operate a motorboat. Aged ten years and less than twelve years of age may only operate under a parent or guardian's direct control.

#### Who Must Take the Course?

No person born on or after January 1, 1998, unless exempted by subsection (i), shall operate a motorboat with over ten horsepower unless that person has a valid Boating Safety Certificate issued by the Department of Natural Resources or an entity or organization recognized and approved by the Department.

Persons at least 12 years of age and less than 18 years of age may only operate a motorboat if:

They have in possession a valid Boating Education Certificate of Competency issued by the Illinois Department of Natural Resources, Safety Education Division, or they are accompanied on the motorboat and under the direct control of a parent or guardian or a person at least 18 years of age designated by a parent or guardian.

Throughout the year, many people operate motor-driven watercraft on Illinois waters, and many operate for the first time. So, we encourage individuals - both novice and experienced - to take the course. Each of us has the responsibility to keep this lifetime leisure activity free from tragedy and personal loss to ourselves and our fellow boaters. The Illinois Boating Education Course is offered with these objectives in mind.

The Illinois Boating Education Course consists of a minimum of eight hours of instruction. These courses cover the basics of boating safety, equipment and requirements, navigation, motorboat, registration and titling, emergency measures, and the Illinois boating laws.

The program is primarily designed to train young people over the age of 12 years old. The educational material is based on a sixth-grade reading level. Students under the age of 11 may not participate in the exam to receive certification. Students 11 years old will receive their certificate upon their 12th birthday.

Persons 12 and over completing the minimum eight hours of instruction and successfully completing the final examination will receive a State of Illinois Certificate of Competency.

#### Two Ways to Take the Course

**Instructor-led Classes-**The traditional class method is through an 8-hour instructor-led class structure. Classes may be taught in one day or over a couple of different days, usually on the weekend. The class will end with an exam to pass the class. Interested individuals may call 1-800-832-2599 or check the <u>List of Education Courses by County.</u>

Online Self-Study Course-Students may study the course material at their own pace, completing chapter reviews along the way. At the end of the course material, the student will be required to pass an exam. Student certification will be mailed by the course provider.

#### **REGISTERED RECREATIONAL BOATS**

Illinois requires every watercraft, except non-powered watercraft, on waters within the jurisdiction of this State to be numbered. No person may operate, or give permission for the operation of, any watercraft on such waters unless the watercraft is numbered in accordance with the Boat Registration & Safety Act, in accordance with applicable Federal law, or in accordance with a Federally-approved numbering system of another State, and (1) the certificate of number awarded to such watercraft is in full force and effect, and (2) the identifying number set forth in the certificate of number is displayed on each side of the bow of such watercraft.

The owner of each watercraft requiring numbering by this State shall file an application for number with the Department of Natural Resources on forms approved by it. The application shall be signed by the owner of the watercraft and shall be accompanied by a fee as follows:

They did not wear life jackets, and it was later discovered that no life jackets were aboard the canoe. The cause of death was drowning.

3) On 05/13/22 at approximately 10:40 PM, the victim and three friends were boating on Lake Shelbyville. The four men had launched the operator's boat from the Bo Wood boat ramp. The victim was sitting on the front deck of the boat, facing the rear, with his feet on the floor. The operator headed west from the boat ramp at a cruising speed. The men stated that as the operator maneuvered to the right, the victim lost balance from his seated position and fell out of the boat over the port side. One of the passengers placed a life jacket on and dove into the area w. ere he saw the victim's hand. He was unable to make contact with the victim, and they did not see him again. On 5/14/22, the victim's body was located, and he was pronounced dead at 11:10 PM. The cause of death was drowning, with cold exposure (hypothermia) as contributing factor.

4) On 5/28/22 at approximately 4:29 PM, the victim, along with 19 other passengers, were docked on the boat at the Springbrook Marina on the Illinois River in LaSalle County. Passengers stated they got on the boat around 2-2:30 PM. The victim drove the boat from the slip to the fuel dock. The boat was not maneuvering properly as the port side motor was running, but the starboard motor was not running. The boat was also fueled with 273 gallons of gas. Passengers reported they smelled gas fumes coming from the cabin, and they also saw fuel in the water. The boat exploded and was fully engulfed. Fifteen passengers onboard the boat were injured. Due to the explosion, a pontoon boat, a PWC, and the fuel station were damaged. The victim was life-flighted to Loyola Hospital due to burns on his body. The emergency personnel transported the rest of the injured to the Morris and Ottawa hospitals. On 6/24/22, the victim died From his injuries sustained in the explosion.

5) On 6/27/2022 at approximately 8:56 PM, the victim was attempting to tie off the bow of his vessel to the dock when he slipped and fell from the boat into the water. The victim was not wearing a PFD at the time of the accident. The passenger on board heard the victim fall overboard and saw him struggling to remain at the surface of the water. The passenger attempted to help the victim but was unsuccessful. The passenger then called 911 and waited for police and fire to arrive. The fire department was able to retrieve the victim from the water. The victim was pronounced deceased at 11:57 PM. No foul play was suspected. Cook County Medical Examiner's Office did not perform an autopsy or toxicology.

6) On 8/17/22 at approximately 7:00 PM, the victim and six other passengers were on a boat located on Lake Michigan. The victim and six passengers boarded the vessel at 31<sup>st</sup> Street Harbor. The victim fell overboard while the boat was on plane near Anchorage Area "C." The person was in the water for approximately 2 minutes and did not resurface. USCG was the first to arrive on the scene. Another passenger was transported to Northwestern Hospital. On 8/20/22 at approximately 4:46 PM, the victim was recovered from Anchorage Area "C." The cause of death was drowning.

#### **Glossary**

Airboat - A vessel that is typically flat-bottomed and propelled by an aircraft-type propeller powered by an engine.

**At Anchor** - Held in place in the water by an anchor; includes "moored" to a buoy or anchored vessel and "dragging anchor".

**Auxiliary Sail** - A vessel with sail as its primary method of propulsion and mechanical propulsion as its secondary method.

Cabin Motorboat - A vessel propelled by propulsion machinery and providing enclosed spaces inside its structure.

**Canoe** - A small narrow boat propelled by paddles. Canoes usually are pointed at both bow and stern and are normally open on top but can be covered.

**Capsizing** - Overturning of a vessel.

**Carbon Monoxide Poisoning** - Death or injury resulting from an odorless, colorless gas generated from auxiliary boat equipment (stoves, heaters, refrigerators, generators, hot water heaters, etc.), another boat's exhaust, or the exhaust of the vessel on which persons were either aboard or in close proximity.

**Collision with Fixed Object** - The striking of any fixed object above or below the surface of the water.

**Collision with Floating Object** - Collision with any waterborne object above or below the surface that is free to move with the tide, current, or wind, except another vessel.

**Collision with Commercial/Governmental/Recreational Vessel** - Any striking together of two or more vessels, regardless of operation at the time of the accident, is a collision.

**Collision with Submerged Object** - A boat's collision with any waterborne or fixed object that is below the surface of the water.

**Congested Waters** - Where the body of water is either too small or narrow to safely accommodate the number of boats on it.

Cruising - Proceeding normally, unrestricted, with an absence of drastic rudder or engine changes.

**Departed Vessel** - An accident where a person voluntarily disembarks a vessel by his/her own will (i.e., by diving off, jumping in), as opposed to a case where the person is forcefully ejected by a change in the vessel speed and/or direction.

**Documented Vessel** - A vessel of five or more net tons owned by a citizen of the United States and used exclusively for pleasure with a valid marine document issued by the Coast Guard. Documented vessels are not numbered.

**Drifting** - Underway but proceeding over the bottom without the use of engines, oars, or sails; being carried along only by the tide, current, or wind.

**Electrocution** - Death or injury resulting from an electrical current that comes in contact with water causing electrocution of the victim.

**Excessive Speed** - Speed above that which a reasonable and prudent person would have operated under the conditions that existed. It is not necessarily a speed in excess of a posted limit.

**Failure to Vent** - Prior to starting the engine, failure to turn on the powered ventilation system that brings in "fresh air" and expels gasoline vapors from the engine compartment.

Fall in Vessel - Any operator or passenger who slips, trips, or falls on board or within the vessel.

**Falls Overboard** - Any operator or passenger who falls off of the vessel.

**Fiberglass hull** - Hulls of fiber-reinforced plastic. The laminate consists of two basic components, the reinforcing material (glass filaments) and the plastic or resin in which it is embedded.

**Fire/Explosion (fuel)** - Accidental combustion of vessel fuel, liquids, including their vapors, or other substances such as wood.

Fire/Explosion (other) - Accidental burning or explosion of any material onboard except vessel fuels or their vapors.

**Flooding/Swamping** - Filling with water, regardless of method of ingress, but retaining sufficient buoyancy to remain on the surface.

**Force of Wave/Wake** - The track in the water of a moving boat; commonly used for the disturbance of the water (waves) resulting from the passage of the boat's hull.

**Fueling** - Any stage of the fueling operation; primarily concerned with the introduction of explosive or combustible vapors or liquids on board.

Grounding - Running aground of a vessel, striking or pounding on rocks, reefs, or shoals; stranding.

**Hazardous Waters** - Rapid tidal flows (the vertical movement of water) and/or currents (the horizontal flow of water) resulting in hazardous conditions in which to operate a boat.

**Houseboat** - A motorized vessel that is usually non-planing and designed primarily for multi-purpose accommodation spaces with low freeboard and little or no foredeck or cockpit.

**Hull Failure** - Defect or failure of the structural body of a vessel (i.e., hull material, design, or construction), not including superstructure, masts, or rigging.

Ignition of Spilled Fuel or Vapor - Accidental combustion of vessel fuel, liquids, and/or their vapors.

**Improper Anchoring** - Where a boat is either in the process of being anchored incorrectly or incorrectly held in place in the water by an anchor.

**Improper Loading** - Loading, including weight shifting, of the vessel causing instability, limited maneuverability, or dangerously reduced freeboard.

**Improper Lookout** - No proper watch; the failure of the operator to perceive danger because no one was serving as a lookout, or the person so serving failed in that regard. Every vessel shall at all times maintain a proper look-out by sight and hearing as well as by all available means appropriate in the prevailing circumstances and conditions so as to make a full appraisal of the situation and the risk of collision.

**Inboard**– An engine mounted inside the confines of a vessel that powers a drive shaft that turns a water jet impeller or that runs through the bottom of the hull and is attached to a propeller at the other end.

**Inflatable -** A vessel that uses air-filled flexible fabric for buoyancy.

**Kayak** - A small boat with a cockpit that is propelled by a double-bladed paddle by a sitting paddler.

**Inadequate On-board Navigation Lights** - Insufficient and/or improper lights shown by a boat that indicate course, position, and occupation, such as fishing or towing.

**Machinery Failure** - Defect and/or failure in the machinery or material, design or construction, or components installed by the manufacturer involved in the mechanical propulsion of the boat (e.g., engine, transmission, fuel system, electric system, and steering system).

Missing or Inadequate Navigation Aids - The absence of or ineffective presence of navigation aids.

Motorboat - Any vessel equipped with propulsion machinery.

Navigation Rules Violation - Violation of the statutory and regulatory rules governing the navigation of vessels.

**Numbered vessel** - An undocumented vessel numbered by a state with an approved numbering system under Chapter 123 of title 46, U.S.C.

**Open Motorboat** - A vessel equipped with propulsion machinery and having an open load-carrying area that does not have a continuous deck to protect it from the entry of water.

**Operator Inattention** - Failure on the part of the operator to pay attention to the vessel, its occupants, or the environment in which the vessel is operating.

**Operator Inexperience** - Lack of practical experience or knowledge in operating a vessel or, more particularly, the vessel involved in the accident.

**Outboard** - An engine with a propeller or water jet integrally attached, which is usually mounted at the stern of a vessel.

**Overloading** - Excessive loading of the vessel causing instability, limited maneuverability, dangerously reduced freeboard, etc.

**Paddlecraft** - A vessel powered only by its occupants, using a single or double-bladed paddle as a lever without the aid of a fulcrum provided by oarlocks, thole pins, crutches, or similar arrangements.

**People on Gunwale, Bow, or Transom** - Standing/Sitting on the upper edge of the side of a boat, usually on a small projection above the deck; and/or standing/sitting on the most forward part of the boat; and/or standing/sitting on the back of the boat.

**Person Struck by Vessel** - A person is struck by a boat.

**Person Struck by Propeller** - A person is struck by the propeller, propulsion unit, or steering machinery.

**Personal Watercraft** - A vessel propelled by a water-jet pump or other machinery as its primary source of motive power and designed to be operated by a person sitting, standing, or kneeling on the vessel rather than sitting or standing within the vessel's hull.

**Pod drive**- An engine mounted in front of the transom of a vessel and attached through the bottom of the hull to a steerable propulsion unit.

**Pontoon Boat** - A vessel with a broad, flat deck that is affixed on top of closed cylinders which are used for buoyancy, the basic design of which is usually implemented with two rows of floats as a catamaran or with three rows of floats as a trimaran.

**Restricted Vision** - A vessel operator's vision is said to be restricted when it is limited by a vessel's bow high trim or by glare, sunlight, bright lights, a dirty windshield, spray, a canopy top, etc.

**Rowboat** - An open vessel manually propelled by oars.

Sail (only) - A vessel propelled only by sails.

**Sharp Turn** - An immediate or abrupt change in the boat's course of direction.

**Sinking** - Losing enough buoyancy to settle below the surface of the water.

**Skier Mishap** - Skier mishap is defined by persons (1) falling off their water skis, (2) striking a fixed or submerged object, or (3) becoming entangled or struck by the tow line. Also includes mishaps involving inner tubes and other devices on which a person can be towed behind a boat.

**Standup Paddleboard** - A vessel, typically 7' - 15' in length with enough width and flotation to stay afloat without momentum while boarded, that is propelled by a standing operator with the use of a single or double-bladed paddle.

Starting in Gear - The boat's engine is started with the transmission in forward or reverse.

Steel hull - Hulls of sheet steel or steel alloy, not those with steel ribs and wood, canvas, or plastic hull coverings.

**Sterndrive** - An engine, powering a propeller through a series of shafts and gears, mounted in front of the transom of a vessel and attached through the transom to a drive unit that is similar to the lower unit of an outboard; and may also be known as an inboard-outdrive or an inboard-outboard.

**Sudden Medical Condition** - An incident where a person on a vessel experiences an unexpected medical condition.

**Towing** - Engaged in towing any vessel or object other than a person.

**Weather** - As a contributing factor of an accident, "Weather" is supposed to signify a stormy or windy condition, usually connoting rough or high seas and dangerous operating conditions.

**Wood Hull** - Hulls of plywood, molded plywood, wood planking, or any other wood fiber in its natural consistency, including those of wooden construction that have been "sheathed" with metal.

You will receive a new registration card and two IL decals in the mail within three weeks of renewing.

#### Watercraft Regulations and Tax Questions

Do I have to title my boat?

Titling is optional for watercraft under 22 feet in length. Registration requirements have not changed. All watercraft powered by machinery (this includes trolling motors) or sail are required to be registered in Illinois.

What class is my boat?

- Class 1- All powered watercraft less than 16 ft. and all motorized canoes, kayaks, and paddleboats, regardless of length.
- Class 2 16 ft. to less than 26 ft.
- Class 3 26 ft. to less than 40 ft.
- Class 4 40 ft. and over

How much does it cost to title/register my boat?

Watercraft **under 22 feet in length** applying for registration only will pay the renewal fee. A \$2.00 processing fee will be added to all watercraft application transactions.

Do I still need to purchase a water usage stamp for my canoe/kayak?

The law that took effect on June 1, 2018, repealed the requirement of the water usage stamp for non-powered watercraft. The water usage stamp is no longer available for purchase.

Unpowered watercraft are not required to be registered in Illinois. Unpowered vessels are sailboats or vessels that are paddled, poled, or rowed. You may choose to register your unpowered watercraft.

Titling is optional for all watercraft under 22 feet in length.

Watercraft registration requirements have not changed. All watercraft powered by machinery (this includes trolling motors) or sail are required to be registered in Illinois.

I have not yet received my watercraft title, registration card, or decals. Can I still go boating?

Yes. Please keep the temporary permit copy of the watercraft application you completed or the Online receipt page with you while boating in Illinois until your paperwork is processed.

I purchased a boat without a title. How can I title the boat in my name?

Please provide the IL registration number for the watercraft, along with the seller's name(s). If the boat was previously titled, you are required to surrender the original, properly endorsed watercraft certificate of title issued in the seller's name(s) when applying for title/registration.

What equipment is required for me to legally operate my watercraft?

Boat Scrapped, Junked, or Destroyed

- The Department of Natural Resources must be notified within 15 days if a watercraft is scrapped, junked, or destroyed.
- Surrender current title; NO fee required.

#### The owner must surrender the title, and such boat will not be registered or titled again.

- Rut- 75 if purchased from an individual; if purchased from an out-of-state dealer, then you would complete a Rut -25, or the Illinois dealer would complete an ST 556.
- 2 copies of the bill of sale
- Tax fee payable to the Illinois Department of Revenue
